# Evidence-based Practice Center (EPC) Program



- Established in 1997
- Develops systematic reviews and other products to improve quality, effectiveness, and appropriateness of healthcare by synthesizing evidence and facilitating translation of evidencebased research findings.
- Maintains pool of EPC contractors through IDIQ master contracts that last ~5 years
  - Topic assignments awarded through limited competition between EPCs






#### EPC Program Develops Methods for Evidence Synthesis



## How are EPC Evidence Reports used?







## EPC Evidence Reports Inform Coverage Decisions



- CMS considering coverage changes for home mechanical ventilators
- EPC produced technology assessment report (<u>https://www.cms.gov/Medicare/Coverage/DeterminationProcess/downloads/id108TA.</u> pdf)



- Published JAMA article (<u>Wilson ME, et al. JAMA 2020</u>)
- Presented findings at Medicare Evidence Development & Coverage Advisory Committee meeting 4/2020
- Coverage decision changes under discussion at CMS

## **Technical Brief**



- Rapid report on key issues related to an intervention such as relevant patient populations and subgroups of interest
- Focused on interventions with limited published data
- Maps out the evidence rather than grade its strength or certainty (vs. systematic review)

# Advantages of AHRQ EPC Reports



- Established methods for evidence synthesis
- Transparency
- Stakeholder engagement
  - Key Informants/Technical Expert Panel
  - Public input sought throughout evidence report development process
- Partner engagement
  - Monthly calls with AHRQ and EPC
  - All deliverables reviewed by partners
