Division of Cancer Control and Population Sciences
National Cancer Institute

This position involves coordination of implementation science efforts across the cancer control continuum. One major component of this work is identifying the contributions of Implementation Science to the research agenda across the Division. A second component is overseeing the development, maintenance and evolution of multiple platforms (e.g. Consortium for Cancer Implementation Science, TIDIRC Open Access, Implementation Science Webinars, Evidence-Based Cancer Control Programs, etc.) that bridge research, practice and policy. A third component is the development of initiatives to advance dissemination and implementation research across the Institute, Agency, Department, and broad research community. This involves serving as a principal spokesperson for the growth of the knowledge base underlying the dissemination and implementation of evidence-based clinical and community practice. I founded an NIH-wide working group on dissemination and implementation research, including representation from 23 Institutes, Centers and Offices. This working group continues to plan agency workshops, funding announcements and training activities for D&I research. In addition, I serve on multiple committees within the Institute, NIH, and outside of HHS, and as a primary contact within NIH on issues related to Implementation Science. As Deputy Director for Implementation Science, I also represent the Division in NCI, NIH and external meetings and conferences and participate in Senior Level planning around programming, budget, HR, and scientific agenda-setting.
